## **Nuheat Privacy Policy**

This Privacy Policy describes the information that Nuheat Industries and its subsidiary ("we," "our" or "us") collects through the <u>www.nuheat.com</u> and the <u>www.mynuheat.com</u> websites (each, a "Site") and any mobile application of ours (each, an "App") (collectively, the "Service") and how we use it, how we protect it and the choices you can make about your information. ### CONSENT:

## How We Use Your Information

We use the information that we collect for the following purposes, including:

- The purposes for which you provided it;
- To respond to your inquiries;
- For fulfillment of requests;
- To identify you as a user of the Service;
- To send you information about your relationship with us;
- To allow you to participate in surveys;
- To contact you with information, including promotional information, that we believe will be of interest to you, done either by us or a third party;
- To process and respond to your inquiries;
- To improve the Service or develop new services;
- To provide the services you request, including the Service and any notifications or updates relating to the Service;
- For research that we or a third party may perform regarding the Service;

- To create anonymous data, which we may use for any purpose;
- To compile aggregate data for internal and external business purposes;

## How Your Information is Disclosed

- 1. <u>Third Parties</u>. We may use third parties to perform functions in connection with the Service (for example, Web hosting, data analysis and marketing services, etc.). - 2. <u>Business Changes</u>. - Protect against legal liability;

- 5. <u>Aggregated Anonymous Information</u>. We may share aggregated anonymous information relating to visitors to and users of the Service with affiliated or unaffiliated third parties.
